UNFINISHED BUSINESS:

- 1. Four (4) relevant committee reports were given:

NEW BUSINESS:

- 2. Discussion was held on contacting Mary Racila, a resident, about possibly serving on the Board to help with Quickbooks, Excel, etc. A meeting will be set up with Mary and Board members that would be able to attend. This position also should be opened to the floor at the next general meeting for other residents that might also want to volunteer.
- 3. It was suggested that since Crane Lakes has no evacuation plan in place for emergencies, our website should add a link connecting to the Volusia County emergency services site which is continuously updated.

- 4. Due to recent vandalism to some of our homes near Bald Eagle and Purple Martin, it was suggested that management might want to add some cameras in that area.
- 5. CLHOA now has a credit card. The procedures for using the card will be the same as cash. Expenditures require Board approval at a General Meeting and then the order(s) will be placed by the Treasurer.
- 6. We plan to move forward with online elections for officers. An Election Committee will be formed to work with Joe Peterson.
